## Auction Terms, Rules & Conditions

**ALL** items are sold “**AS IS, WHERE IS**” without guarantees of any kind. It is your responsibility to inspect all items prior to placing a bid. Failure to inspect an item will not release your obligation to purchase it. When the Auctioneer says “Sold,” the high bid is accepted on an item and the sale is **FINAL**.

Once you, the Buyer, have won the bid on an item, it becomes your property and responsibility. The Auctioneer and his staff do their best, but cannot, and will not, be responsible for securing your items. No refunds will be given for missing items. Also, Buyers are responsible for providing their own crews and packing/moving materials to facilitate the pick-up of their purchases. Our insurance prohibits our staff members from assisting customers in removal of purchases.

Please refer to the catalog of the auction for which you are registering to determine whether it is taxable or tax exempt. Only dealers buying for resale who have a valid, **current** tax exempt form on file with the cashier will be exempt from paying sales tax if the auction is taxable. A 10% Buyers Premium, which is also taxable, will be added to each winning bid.

**As soon as the auction ends, you must pay for your purchases in full.** You may not move or remove your purchases until you have a paid receipt. You have until the posted time (see catalog) to remove all purchases. If all purchases are not removed by the specified time you will forfeit your rights to the items as they will be considered abandoned.
